Notes

This list of responses provides information on how the responses have been categorised for the purposes of the analysis. In total we have processed 356 responses. A number of respondents submitted two responses in different capacities. These have been counted as separate responses. Where respondents submitted more than one response in the same or closely linked capacities, these were usually linked under one response number, or one of the responses was withdrawn*. The categorisation in the list above is as follows:

- **Response number and origin (if not from England)**

Most responses were numbered sequentially as they arrived at the Department. Though some of the responses were from outside of England and Wales, we have considered their content in relation to the legislation here. The Scottish and Northern Ireland Executives are also being made aware of the response. Respondents were asked to highlight any specific issues that had arisen with the operation of the legislation in Wales, but none came to light

- **Type of response (subsector and format)**

All responses submitted in the form of standard letters drafted by particular trade associations and signed by firms have been considered as submitted by firms. Where different individuals in the same firm have submitted identical responses, these have been treated as one response. Standard responses have been categorised into three types (Construction Confederation, National Specialist Contractors' Council and Specialist Engineering Contractors' Group).

Responses to the questions in the form in Annex 4 of the consultation paper that were processed for statistical analysis are marked "Q&A" on the list. A fuller explanation of the statistical analysis is provided in annex 4 of the analysis of responses. We removed from the statistical analysis any responses which were clearly photocopies or duplicates of other responses we had received. These are recorded as "non standard responses" and were considered as part of the general qualitative analysis. A wide range of other non standard responses were also submitted, including letters, reports and papers. All of these are marked as "non-standard response".

(*) The only exception to the general rule on consultation responses (marked *) was in including two responses we received from Mr Preou (also both marked *) on the list. He submitted both a standard letter and a completed consultation response form and his two responses have been counted separately so as to count as both kinds.
