Act	Enterprise Act 2002.
Air-Shields business	The assets that represent the neonatal warming therapy products business of Hillenbrand to be purchased by Dräger from Hillenbrand under the Purchase Agreement .
Atom	Atom Medical Corporation, a company incorporated in Japan.
BLISS	The principal charity operating in the neonatal area.
BME	Bio-medical engineering.
CC	Competition Commission.
Central Medical Supplies	Central Medical Supplies Limited, a company incorporated in England and Wales.
Closed care incubator	An incubator which provides a controlled environment for the baby within which temperature, humidity and oxygen levels in the air can be closely controlled.
Dräger	Dräger Medical AG & Co KGaA, a company incorporated in Germany.
Dräger UK	Dräger Medical UK Ltd.
EC	European Community.
Fisher & Paykel	Fisher & Paykel Healthcare Corporation Limited, a company incorporated in New Zealand, and its wholly-owned UK subsidiary.
GE	GE Medical Systems which is a part of General Electric Company and all its parents and subsidiaries.
HHI	Herfindahl-Hirschman Index.
Hillenbrand	Hillenbrand Industries, Inc, a company incorporated in the USA.
Hill-Rom	Hill-Rom, Inc, a company incorporated in the USA.
Hybrid device	A neonatal warming therapy product which can be converted from closed care to open care and vice versa.
Inspiration Healthcare	Inspiration Healthcare Limited, a company incorporated in England and Wales.
Installed base	The neonatal warming therapy devices currently in use in a hospital.

Manufacturer	A company which manufactures one or more neonatal warming therapy products.
Natus	Natus Medical, Inc, accompany incorporated in the USA and its UK subsidiary.
Neonatal warming therapy products	Includes closed care incubators, open care warming beds, transport incubators, phototheraoy products , accessories and the provision of aftercare services.
Neonate	A premature newborn baby.
NHS	National Health Service.
NICU	Neonatal intensive care unit.
Ohmeda	A brand name for neonatal warming therapy products and part of Instrumentarium, a Finnish medical equipment manufacturer which was acquired by GE in October 2003.
OJEC	Official journal of the European Communities.
Open care warming bed	An open cot warmed by an overhead radiant warmer, or by a warmed mattress.
PASA	NHS Purchasing and Supply Agency.
Phototherapy product	A lamp which delivers light in a particular spectrum which is necessary for the treatment of jaundiced babies.
Purchase Agreement	The purchase agreement between Hill-Rom , Hill-Rom Manufacturing, Inc, Hill-Rom Services, Inc, Dräger Medical Infant Care, Inc and Dräger dated 15 September 2003.
Supplier	Includes both manufacturers of neonatal warming therapy products , the manufacturers' own distributors and independent distributors supplying one or more neonatal warming therapy product to hospitals.
SLC	Substantial lessening of competition.
Transport incubator	A self-contained incubator attached to a trolley which is used for moving babies between departments in a hospital or between hospitals.
Trust	An NHS trust.
