

MAXIMUM CASH ALLOCATION MONTHLY PAYMENTS OPTION

The maximum cash allocation may optionally be issued as 12 equal payments. These would be disbursed at the beginning of each month for 12 months if the Property Allocation Number holder for the maximum cash allocation responds and so requests. Payment would then be issued as shown in the schedule at right.

Issuance of the first cheque would occur on or about the first business day in the first month following the completion of procedures required for the disbursement of property allocations.

Monthly payments will only be issued upon the specific request of the cash allocation recipient. Otherwise, payment will be issued in a single lump sum. All payments are issued in the form of a corporate bank cheque.
