

AIRWAVE MM02 APPROVED USERS LIST (“SHARERS LIST”)

APRIL 2002 APPLICATIONS - DECISION

The Telecommunications Act licence held by Airwave MM02 authorises them to run the radiocommunications network for a specified group of emergency service users; the largest of which is the Police. The user group (or “sharers list”) consists of a specified list of government approved users and Airwave MM02 can only provide the Airwave service to user groups that are on the list. The licence provides for additions to be made to the list at the discretion of the Secretary of State, subject to a consultation period of not less than 28 days.

It should be stressed that being on the list does not automatically mean that the user group will take up the Airwave service; any service provider could equally offer to provide radiocommunications for any of the groups on the list.

All applications were assessed against agreed criteria developed to ensure that users had a genuine operational requirement to have instant one-to-one communication with Emergency Services (defined as those organisations permitted to carry blue lights on their vehicles).

In April 2002, the DTI consulted on applications from nine organisations wishing to be added to the sharer’s list. This was the first consultation under a revised procedure, approved in February 2002, that standardised the format of applications and required that they be placed on the DTI’s website to facilitate wider scrutiny. The consultation summarised each application and gave a preliminary decision on whether each user group met the criteria. The consultation closed in May 2002.

A summary of the result and a copy of the revised list are attached. Because of the comprehensive nature of this list, it is not expected that significant numbers of additional organisations will be added to the list in the future.

Integrated Incident Management Personnel (1,600/4,760)	Highways Agency	YES	Attend emergencies (most often road traffic accidents) at the request of the Emergency Services. Request based on the need for real time one-to-one communication with Police officers at the scene of the emergency. Support from M25 Integrated Police Group.
Flood Defence Officers Flood Defence Engineers Navigation Officers (600/7,500)	Environment Agency	YES	Require instant and direct one-to-one communications with Blue Light Emergency Services in emergency situations. Flood Defence Emergency Response Project Report includes requirement for integrated incident management at local level between Police, Fire and the Environment Agency.

RSPCA Inspectors RSPCA Animal Collection Officers (500/660)	Royal Society for the Prevention of Cruelty to Animals	YES	One-to-one communication required with Police officers and Fire Service in animal rescues. Liaison with the Police in dealing with road traffic accidents and dangerous animals. Also written into many local and regional emergency plans. Supported by two police forces.
Roads Maintenance Personnel (500/2000)	Highlands Council	YES	Require one-to-one direct and instant communication with Police, Fire and Ambulance personnel in emergency situations and extreme weather conditions associated with the sparsely populated Highlands of Scotland.
Street Lighting Personnel Environmental Health Dog Wardens (500/2000)	Highlands Council	NO	Lack of evidence of need for instant and direct communications with emergency services officers. Some mention of street light failure/knock-downs but no explanation of the work of the Dog Wardens or their emergency communication requirements.
Transco Gas Emergency Services Personnel (3,500/10,000)	TRANSCO (part of the Lattice Group)	YES	The proposed user group responds to emergencies (i.e. gas leaks) and works closely with Police Officers and Fire Fighters at the scene of emergencies involving gas. The case for operational staff such as cable jointers and linesmen appears particularly weak on the information given so far.</p>
<p>Emergency Response Teams</p>	<p>Nuclear Industry (2)</p>	<p>YES</p>	<p>Users of the National Nuclear Accident Response Communication System (NNARCS) replacement are already approved users. These new proposed users perform the same function as those already approved but are not included under the current definition because NNARCS is not used at these sites. The operational need of these additional, identical user groups is accepted.</p>

Their need for communications with Police Officers is therefore the same as that of Police Officers.</p> <p>These group names will replace “Privatised Police Patrols” to accurately and clearly list the Groups that are approved users.</p> <p>Note: “DTLR” no longer exists following a reorganisation of Government departments. “Government” reflects the fact that various Departments are now responsible for these functions.</p>
