- **Ben Nevis on Blue** by Claude Heath, acrylic on polyester was purchased from the artist.

5 New Home Office building, Marsham Street

5.1 Update of Art Enhancement, Public and Interior Arts Strategies and Communications

GAC Curator: Collection Projects gave a summary to the Committee of the overall progress of the various art strategies for the Home Office project. Gary Webb has now decided to replace a proposed overlaying image on his work with a dimmable green neon light fixture. The Committee agreed that the rotational aspect of the sculpture was integral to the work and advised that it should not be removed.

5.2 Interior Arts Strategy: Approval of final proposal by Toby Paterson

The Committee approved Toby Paterson's final proposal for the art commission for the reception area of the new Home Office building.
