Minutes of the Meeting held on Wednesday 22 November 2006 at the GAC Premises

1. Apologies for Absence

Apologies were received from Stephen Deuchar and Alan Davey.

2. Minutes of the Last Meeting

The Minutes of the last meeting (held on 29 June 2006) were subject to several minor changes. The Committee approved these changes and agreed that the amended Minutes could be signed off by the Chairman outside the Meeting.

3. Matters Arising from the Minutes of the Last Meeting

Recent PFI Projects and the GAC

There was no update to report.

Freedom of Information

The Director reported that enquiries had been received concerning the works of art by Emma Kay and Eva Rothschild commissioned by the Home Office.

4. Acquisitions

Acquisitions since 29 June 2006

The Committee noted the Director's list of acquisitions since the last Meeting.

Decision on Proposed Acquisitions

The Committee approved the purchase of the following works of art:

Bach...six suites for the solo cello

2006 Lambda digital C print mounted on aluminium by Idris Kahn

The Committee approved the purchase of this work from Victoria Miro.

On Moddard's Screen

2006 Oil on canvas by Andy Harper

The Committee approved the purchase of this work from the Artist.

Isle of Wight Aug 97 Sunlight on wood, 2 parts by Roger Ackling.

The Committee approved the purchase of this work from Annely Juda.

Time here becomes space / Space here becomes time by Cerith Wyn Evans
The Director showed images of this neon, made up of two separate pieces. The Committee had discussed this work in the previous Meeting (29 June 2006) and now approved its purchase.

Station 2005 Cast marble resin by Darren Almond.
The Committee reconsidered this work and approved the purchase from White Cube.

The Committee viewed several works by Eva Weinmayr which form part of a 7 piece series ("**Today's Question**"). The Committee asked Adrian George to check on availability of the entire series or to consider how many of the seven works would be appropriate for the Collection.

5. Sculpture for the Ambassador's Residence, Washington, DC

The Director had reported in the previous Meeting that the UK Ambassador to Washington wanted to acquire an outdoor sculpture for display in the Residence Garden. The Ambassador had suggested placing the proposal on hold until the next Ambassador was in Post, which the Committee approved.

6. New British Embassy, Doha, Qatar

The new glass wall of a first floor Meeting Room forms the main commission brief. The Committee suggested that Jonathan Parsons develop his proposals further.

7. Update on New Building and Refurbishment Projects

Department for Constitutional Affairs, 50 Queen Anne's Gate

The Director explained that the proposed artists had experienced problems with access to the building to enable them to formulate proposals, but proposals had been received from several artists. The Committee advised the Director to develop proposals further before putting them forward to the DCA.

British Embassy, Sana'a, Yemen

Adrian George reported that the GAC was working with the FCO and Jenny West to arrange a mutually convenient date for the installation of her work of art.

8. UK Supreme Court, Middlesex Guildhall (DCA)

The Director reported that the DCA had commissioned an extensive art strategy for the building from the freelance consultants Modus Operandi but had asked the GAC to implement the strategy's contents. The GAC had attended several meetings with the project architects, Feilden & Mawson. The GAC was willing to administer an art strategy for the project, but one which it initiated and controlled

itself. The Committee asked the Director to give the issues further consideration, especially following a meeting due to take place with the project art committee, on Friday 24 November.

9. New Home Office Building, Marsham Street

Adrian George updated the Committee on developments concerning works of art commissioned from Georgie Hopton, Simon Periton, Gary Webb and Emma Kay and Eva Rothschild. Work on the joint HO and DCMS Booklet *Art at the Home Office* is progressing well, but its timing was now dependent upon the completion of the remaining works of art. The *Art Trail* had been produced and updated.
