

URGENT FOR THE ATTENTION OF MR. ANDREW GOWERS - IP REVIEW FOR THE UK TREASURY.

Good afternoon,

We have just read the UK Patent Office latest mission statement regarding Intellectual Property and the rights of IP owners and how they seek to ensure that IP is respected. We further read that you have been selected by the UK Treasury to lead an independent review into intellectual property rights in the UK and fully understand that the closing date for comments has now passed.

But we believe this matter is of considerable importance and for you to do an honest job and be independent without showing any bias whatsoever there is a case in point that you need to know about.

Have you had access to all papers from the UK Patent Office - if so you will be aware of a registered design number 2053070. This is a circle of 12 gold stars sitting above the country identifier GB on a blue band and listed as being for the purpose of vehicle registration plates and /or stickers.

You may have seen this on many forms of transport in the UK and now throughout the European Union. Here is the link to the UK Patent Office for the registration <http://webdb4.patent.gov.uk/designs> - you will need to enter the number 2053070.

We innovated this design in 1995 - way in advance of any EU directive or UK statutory instrument - which incidently in **SI 561/2001** legalised this particular design for use on UK products without our permission, notwithstanding the previous 6 years of very detailed correspondence between ourselves and the Dept Transport in the UK, the EU Transport Commission and Commissioner and the UK Patent Office. Here is the **link** to the Dept Transport site - falsely claiming Crown Copyright for our IP.

The statements made by the Minister for Science urging innovation and so called protection are an affront to our rights and the obligations that the UK Patent Office and UK government have.

The UK authorities have deliberately and consistently stolen, infringed and pirated the registered design 2053070 (and now others in this series) - with the full knowledge from the very head of the government - Mr Blair and the Crown. Much correspondence and undoubtable evidence is held on this matter.

We read further with great interest the witterings of the Patent Office on IPRs - **Mr Marchant** - the head of this dysfunctional institution in **writing to us on behalf of his organisation and the Crown states on the 18th. March 2004Given that the Patent Office can take no part in any proceedings for enforcement of your design, I am not able to comment on the specifics of your dispute.... and further he wrote on behalf of Her Majesty The Queen on 7th. May 2004.....we are not able to advise or influence applicants or third parties, whether they are private bodies or individuals, or public bodies such as government departments, on how they should act with regard to any specific registrations.....**

The UK Patent Office is an organisation that fraudulently accepts money from the general public and then turns a blind eye to inter governmental collusion, IP theft, IP infringement and IP piracy. There is no honesty whatsoever within that government agency.

There is a huge amount that we wish to say further about this subject and associated matters, but for now - if you actually receive this mail - before it is weeded out by one of your minions- this is the matter is a nutshell.

- **There is no IP protection in the UK if you have a registered design that is as important as 2053070 clearly is**

- **The UK Authorities and The Crown ignore and belittle IP owners rights and their obligations in obeying their own laws**
- **Government Ministers clearly tell downright lies to lull other 'innovators' to part with their money for government coffers with false promises**
- **When matters are brought to their attention they arrest you, put you in jail, seek to steal your property and hope you will 'disappear' - quite literally in some cases.**

We are in the process of finalising upon our new IP website which is warning the public not to innovate any copyright, trademark or registered design in the UK as it holds no value. We are also - latter part of this year publishing our book **PATENTLY CORRUPT**.

We therefore invite you to include our correspondence and any evidence we can assist you with in respect of your appointment by the UK Treasury.

If we do not receive any reply from you we will assume that you do not wish to consider this fundamental issue by reason of being homogenously attached to this enquiry for obvious reasons and not independent.

In any event your view whether silent or otherwise WILL be included this matter.
