Church Commissioners	[ ]Orders confirming schemes of the Church Commissioners for:–  1. terminating the team ministry established for the benefice of St Andrew, Chelmsley Wood, diocese of Birmingham;  2. terminating the team ministry established for the benefice of Stanley and Tanfield, uniting the benefice with that of St George, South Moor, and establishing a team ministry for the area of the new benefice, diocese of Durham;  3. uniting the benefices and parishes of Elton, Stibbington and Water Newton and designating the first incumbent of the new benefice, diocese of Ely;  4. establishing a team ministry for the benefice of Godalming, diocese of Guildford;  5. appropriating the redundant church of St Matthias, Poplar, to use for cultural, community and education purposes, diocese of London;  6. creating the new parish of Pishill, diocese of Oxford;  7. terminating the team ministry established for the benefice of Tisbury, uniting the benefices of Barford St Martin, Dinton, Baverstock and Burcombe and of Tisbury and establishing a team ministry for the new benefice, diocese of Salisbury;
