

**PATRICIA BROWN - Submission 2**

**Adverse affect on the trial of Tirrell Davis and others in respect of the sensational reporting of the death of Kodjo Yenga which we believe was substantially informed by police information**

In media terms there is a presentation of this case as evidence of gang violence in a "leafy Hammersmith Grove" which is another underlying issue in this case. There seems to be a question about gang violence being brought into the area by the press coverage as if black families did not both own and rent houses in the area.

Besides the information listed below evidencing the kind of information given in the reporting there was significant local coverage of Kodjo's funeral in May 2007. The coded language, the media bombardment would seem to ensure that school children are foreseen as brutal thugs and reported as a notorious street gang, all guilty on arrest.

There were two off duty policeman in a car who were at the scene of the crime who's statements were contradictory. The foreman of the jury was a serving sergeant policeman from a neighbouring borough: this was revealed whilst the jury were in deliberation and gave rise to an appeal although it seems not to have been played out in the failed appeal.
