Church Commissioners                      Eleven Orders confirming schemes of the Church Commissioners for:—

1. dissolving the benefice of St Barnabas, Knowle and Holy Cross, Inns Court, creating the new benefice of St Barnabas, Knowle, creating the new benefice of Holy Cross, Inns Court and establishing a group ministry for the two new benefices, diocese of Bristol;

2. terminating plurality for the benefices of Bromfield with Waverton and of West Newton

and for the benefices of Holme Cultram and of St Cuthbert, Holme Cultram, and uniting those benefices with the benefice of Silloth, Christ Church with St Paul, diocese of Carlisle;

3. uniting the parishes of St Andrew, Blackhall and of St John with St Mary, Monkhesleden, diocese of Durham;

4. terminating plurality for the benefices of Downam Market with Bexwell and of Crimplasham with Stradsett, creating the new benefice of Bexwell, uniting the benefices of Downham Market and of Crimplasham with Stradsett, and uniting the benefices of Denver, of Ryston with Roxham, of West Dereham and of Bexwell, diocese of Ely;

5. dissolving the benefices of Falfield with Stone and Woodford and of Oldbury-on-Severn with Hill and Rockhampton, creating the new benefice of Stone with Woodford and Hill, creating the new benefice of Falfield with Rockhampton, creating the new benefice of Oldbury-on-Severn with Shepperdine, creating the new benefice of Berkeley with Wick, Breadstone, Newport Stone and Hill, and by subsequent unions creating the new benefices of Cromhall, Tortworth, Tytherinton, Falfield and Rockhampton, and of Thornbury and Oldbury-on-Severn with Shepperdine, diocese of Gloucester;

6. creating a new parish of Doddington, within the benefice of Skellingthorpe and Doddington, diocese of Lincoln;

7. appropriating part of the churchyard of St George-in-the-East to use for educational and community purposes, diocese of London;

8. declaring redundant the church of St John the Evangelist, Norton-le-Clay, diocese of Ripon and Leeds;

9. terminating the team ministry established for the benefice of Southborough St Peter with Christ Church and St Matthew, and uniting that benefice with the benefice of Bidborough, diocese of Rochester;

10. creating the new benefice of Kidbrooke St Nicholas and terminating the team ministry established for the benefice of St James, Kidbrooke, diocese of Southwark;

11. uniting the benefices of Knottingley and of Kellington, diocese of Wakefield;
