The window of the police car knocked and the Sgt [REDACTED] waved at me. I walked into Boots chemist, came out of Boots chemist and went across to Superdrug. My wife went into Superdrug and I stayed outside to smoke. There was a foot patrol of three police officers coming through the town. There was one taking his radio off and putting it to his ear. At the same time Sergeant [REDACTED] was talking into his radio. I noticed the police officer look over towards me so I walked into Superdrug. The policeman came

replied, "Why are you asking me as you already know it". Again he said, "Mr C150 what's your name". I gave him my name and address.

He let a loud laugh out of him and walked out. When we came out of Superdrug and walked across the road past the police car, it was still sitting outside Wellworths. Sgt [REDACTED] started making kissing signs

at my wife. We walked through the front of Wellworths and out the back. The police car was out the back in the car park. We went into

Iceland. It was then I said to my wife I was going to the solicitor

to tell her what happened. I left Iceland, went across the car park

and a black police car came out of the car park at the same time. On

my way down through the town to the solicitors this same police car

passed me four times. Each time it got to me it slowed down and

travelled past very slow. I got to my solicitors at 1 o'clock which

was lunchtime. I said I would call back after lunch. On my way back

up the town I met my daughter. She walked up the town with me passing

the foot patrol of these policemen, one of them clicked the safety of

his rifle, two clicks, as his rifle was pointed at me. I went back up

to meet my wife. I just feel it was total harassment.
