PARTICULARS OF INTERVIEW

TOMAN was brought from his cell to interview Room N^o 6 by D/c Walker and uniform escort. We introduced ourselves to him and told him we were making enquiries into a bomb attack on an RUC patrol at Levin Road Kilwilke Estate Lurgan at 10.15pm on 6/2/97. In attack carried out by the P.I.R.A. He was cautioned in the following terms, "You do not have to say anything, but I must caution you that if you do not mention when questioned, something which you later rely on in court it may harm your defence. If you do say anything it may be given in evidence".
